**New Deck  
Installation  
to Begin**

As we continue to strive to make Hunter Glen a premiere community in Zionsville we are making some significant changes and improvements along the way. As we had mentioned previously in a mailing, the deck boards on every unit at Hunter Glen will be replaced with a new composite decking material. This material is similar to Trex decking and will not fade or wear like wood decking. We are aware several units are in need of repairs or replacements to their decking, all of this will be remedied with this replacement. These decks will look new for many years to come, helping to increase the overall value of individual units in the community.

**Work is set to begin Monday, February 19th, 2018 and will begin with building 1 on the attached map and move in numerical order through the community. The pace of this project will be determined by community cooperation and weather.**

**A notice will be posted on your front door giving each unit notice when work is to begin on that building. Please check daily for these notices.**

**During this process we need homeowners to:**

- \* Remove all items from your deck.— including any items hanging on your railings—we can't perform work with items on the deck.
- \* Please take note of any and all street closings during construction. These streets are closed for your safety and we are not responsible for tire damage if these closings and regulations aren't followed. If you need immediate access please ask any member of construction on the property and they would be happy to assist you.
- \* Please remove all vehicles from the driveways by 8am for your date(s) of construction— we absolutely can not complete decking work with vehicles in the driveway.
- \* Your deck will not be accessible during this process. Please be mindful of the construction and ensure that doors are locked so children and adults don't attempt to use a deck that is under construction.

**If You Rent Your Unit**

**It is your responsibility to notify your tenant. Please go through this information with them and ensure that they're aware of the process and requirements. We can't replace your deck boards if these processes are not completed.**
